#### First season meeting

### **Place: Continental Country Club**

Meeting called to order by President Al Smith At 1:00 pm

President Smith reminded the Board that each participant, player, coach's, umpires must fill out the new waivers, release liability and covid along with new contracts. These reflect the league incorporated status.

#### Pledge of Allegiance

**Treasurers Report:** Read and accepted on a motion by Sunlake, seconded by Hawthorne and carried by voice vote.

**Old Business:** Bob Andrews was officially confirmed as vice president on motions by Sunlake, Pennbrooke and carried by voice vote.

**Divisional Awards:** D1: Legacy, D2: Water Oak, D3: Continental, D4: Continental, D5: Water Oak, D6: Legacy.

President Smith presented a new award, "The Evil Empire Award" based on the community that had the best overall winning percentage for all of its team, went to Water Oak.

### Reports of Committees: OPCOMM.

- Communities seeking admission to the SFSSI and recommended for approval, Royal Highlands. Royal Highlands was accepted back into the league on motions by Sunlake, 2<sup>nd</sup> by Hawthorne and carried by roll call vote.
- The opcomm committee recommended the acceptance of (2) club teams into division 1. Ocala Club Team, and Clermont (Flatwood) Club Team. After discussion's both teams were accepted into division 1 on a one-year trial basis on motions by Sunlake, 2<sup>nd</sup> Rec Plantation and carried by roll call vote.
- The acceptance of the following new community teams: **Division 4:** Royal Highlands, **Division 5:** Royal Highlands, Clerbrook, **Division 6:** Holiday Village and Stonecrest was carried by roll call vote on motions made by Pennbrooke, Sunlake.
- <u>The divisional alignment:</u> Approved on a motion made by Plantation, 2<sup>nd</sup> by Stonecrest and carried by roll call vote.
- Tentative scheduling dates are as follows: November 3 thru November 20, Thanksgiving break, December 1, thru December 19, Christmas break, January 1, thru March 19.

- Pennbrooke, Legacy, Holiday Village, Stonecrest and Royal Highlands were granted the use of
  outside players for this playing season on motions made by Sunlake, Pennbrooke and carried by
  voice vote. I may have missed one community with the noise level.
- Alignment was approved on motions made by Plantation and Stonecrest and carried by roll call vote.
- SummerGlen and Lakes @ Leesburg have been placed on inactive status for this physical year.
- Communities are required to have and post covid guidelines for visiting communities and posted on the web site.
- President Smith mentioned that the use of players from Lakes @ Leesburg, and SummerGlen
  may be a possibility to enhance community teams that might be short of players due to the
  covid virus.

#### **Web Master Report:**

Maryann discussed the new software purchased at a cost of \$500.00. To cover the cost each community and club team will be assessed a one-time fee of \$50.00 to cover that cost. SummerGlen and Lakes @ Leesburg deemed inactive this season will be assessed the \$50.00 fee upon re-admittance to the league.

## **New Business:**

- The need for new waivers and contracts was discussed by President Smith.
- All Star game will take place on the 2<sup>nd</sup> or 3<sup>rd</sup> Saturday in February hosted by Holiday Village.
- The new USA bat stamp replacing the ASA stamp on new bats was discussed by Bob Andrews.
- The managers meeting will be held at CCC on October 23 at 11:30 at the ball park pavilion.
- The Board meeting will take place following the managers meeting at 1:00 pm.
- Discussion was initiated by Plantation on freezing the current rosters of club teams.
- Discussion was initiated by Plantation to allow division 1 to have unlimited players under age 55 over 50 years of age to play. Based on this discussion a motion was made by Plantation 2<sup>nd</sup> by Del Webb to allow unlimited D1 players. The motion was approved on a roll call vote 8 in favor and 6 against.

**Note:** This motion is <u>Null in Void</u> as it is in conflicts with established league rules under the roster section, 2.3, 2.2 and 2.1. Game(s) played that do not follow established SFSSI rules will be consider a forfeit.

- Motion to adjourn made by Pennbrooke, 2<sup>nd</sup> by Sunlake and carried.

# **Discussion Topic:**

I was approached after the meeting and ask if I could determine the amount of time allotted to topics around division one. The meeting lasted 128 minutes and of that time 84 minutes involved division one issues.
