**Waiver, Release of Liability & Indemnification Agreement (Player, Coach, Umpire)**

I, the undersigned player, acknowledge, agree and understand that: Voluntary and of my own free will, I elect to participate as a member of the softball team and league indicated below.

I understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to me or other players including, but not limited to, those hazards associated with weather conditions, playing conditions, equipment, field conditions and other participants.

I understand that the very nature of the game of softball is hazardous and risky, including but not limited to, the acts of pitching, throwing, fielding and catching of the ball, the swing of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, I, the undersigned, agree that in consideration for the right to play or participate as a member of the team or community designated below and in consideration for permission to play or participate on fields arranged for me by the team or the Sun and Fun Tri County Senior Softball League, Inc. (SFSSI)

I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing, playing or participating as a member of the team or community designated below, (b) while serving in a non-playing capacity as a team member during practice or play by other teams or by players on my own team, and (c) while on or upon the premises of any and all of the fields arranged for me by my team or the Sun and Fun Tri County Senior Softball League, Inc. for practice or play.

I release, discharge and agree not to sue the team, Sun and Fun Tri County Senior Softball League, Inc.(SFSSI) the field owner or other entity designated below, or their owners, officers, agents, servants, associations, employees, or any person or entity connected with the team, Sun and Fun Tri County Senior Softball League, Inc., or field owner for any claim, damages, costs or cause of action which I have or may have in the future as a result of injuries or damages sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of parties hereby released.
