1. The meeting was called to order by President Jim Maguire.
2. The minutes of the 9-14-2015 meeting were approved.
3. Treasurer Bryan Carmack was unable to attend, but we should still have $\$ 835.02$ in the checking account.

New Business
4. The new division reps recorded above were elected at the meeting. We thanked for them for their help.
5. Jim Milligan will take over as Treasurer.

Old Business:

1. Important dates for the 2015-2016 season:

November 3 - first game day
March 18 - final game day
March 21 - Del Webb tournament starts and goes for 4 days.
2. Division alignment for the 2015-2016 season was discussed.

Division 1 is set with five teams.
Division 2 - Plantation asked to move to Division 3. Motion passed 8-4
Division 3 - Sun Lake asked to move to Division 4. Motion passed 11-2. Stonecrest was moved to Division 2. Motion passed 9-2. Water Oak will not have a division 3 team.

These moves allow divisions 2,3, and 4 all to have six teams.
Division 5 - Pennbrooke moves to Division 5 and makes eight teams in Division 5. Division 6 - Division 6 will have six teams with two additional teams possible from Spruce Creek and Pennbrooke, (Note added by the Secretary - after the meeting it was confirmed that Division 6 will have eight teams. See the final divisional alignment chart below that reflects the changes made at this meeting.)
3. At the September 14, 2015 meeting, the previous divisional alignment rule (Top team in a division moves up, bottom team moves down) was rescinded by the executive board for the 2015-2016 season. President Jim Maguire appointed a committee to recommend new rules for the divisional alignment for future seasons.
The committee is Greg Alms, Jerry Parks, Bob Falzone, Gene Underwood, and Mitch Silver.
4. Managers met with their division reps and handed out their rosters to the other managers, and rosters and contracts to their Division Rep and the Vice President
5. President Jim Maguire asked if communities were interested in a 70's division. Only two communities expressed interest.
6. Plantation requested a reconsideration of the Trump softball as an approved ball for league use since it could be obtained at lower cost. A motion to do so was not approved.
