

**Sun and Fun Tri County Senior Softball League, Inc. (SFSSI)**

**Waiver, Release of Liability & Indemnification Agreement Non-Membered Club Team (NMCT)**

The undersigned entity **(NMCT)** does acknowledge, agree, and understand that **(NMCT)** and its assigned players, coaches, umpires, and other participants elect to participate as a **(Non-Membered Team)** with no affiliation to the (SFSSI) in division (1) alignment only for a period of one (1) playing season with renewal at the discretion of the SFSSI Board of Directors.

The **(NMCT)** and its players, coaches, umpires, and other participants understand that there are certain risks and hazards involved in participating in softball that may result in injury or death to your players or other players including, but not limited to, those hazards associated with weather conditions, playing conditions, equipment, field conditions, and other participants.

The **(NMCT)** and its players, coaches, umpires, and other participants understand that the very nature of the game of softball is hazardous and risky. Including but not limited to, the acts of pitching, throwing, fielding, and catching the ball, the swinging of the bat, running, jumping, stretching, sliding, diving, and collisions with other players and with stationary objects, all of which can cause serious injury or death to me and to other players.

Further, **(NMCT)** its players, coaches, umpires, and other participants agree that in consideration for the right to play or participate in (SFSSI) scheduled games as a **(Non-Membered Team)** and in consideration for permission to play or participate on fields arranged for playing scheduled or non-scheduled games or practices for the **(NMCT)** by membered communities of the Sun and Fun Tri County Senior Softball League, Inc. (SFSSI)

The **(NMCT)** voluntarily elects to accept and assume all risks of injury incurred or suffered by members of the **(NMCT)** while practicing, playing, or participating as the **(Non-Membered Team)** designated below.

The **(NMCT)** releases, discharges, and agrees not to sue any team or community associated with the Sun Tri County Senior Softball League, Inc. (SFSSI), the officers, or any person or entity connected with the Sun and Fun Tri County Senior Softball League, Inc. or field owner for any claim, damages, costs or cause of action which the **(NMCT)**, its players, coaches, umpires or other participants have or may have in the future as a result of injuries or damages sustained or incurred by the **(NMCT)**, its players, coaches, umpires or other participants from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of parties hereby released.

The **(NMCT)** its players, coaches, umpires, and other participants agree to play games scheduled by the (SFSSI) under the rules adopted by the (SFSSI) for membered communities, their players, coaches, umpires, and other participants.

The **(NMCT)** will not have a voting member on the Board of the (SFSSI), nor be allowed to vote, make, or second motions for a vote, but can and should be involved in discussions pertaining to the (SFSSI) scheduling and play.
